Trails & Equipment

Ron reported that with the recent rains, the trails are in good shape. There were several trees down over by Hap's, a big tree was down that was reported by Forestry. Those have been cleared.

The Baraboo mechanic was out again and fixed the loader bucket and hydraulics.

Swiss Town Board was approached about opening up County Roads 'F' from Brothel Road to Hwy 77 and 'H' up to Hwy 35.

Ron attended the Blaine town meeting - they are opening up all roads within the township to ATVs. Effective date is TBD.

The grant for the bridges on Trail 45 from Brothel Road to River Road was not enough. We are \$3,000 short – the plan is to ask the snowmobile club to split the cost of repairs and we will apply for another grant at a later date.

New Business

Approximately 20 people participated in the Free-Wheeling Weekend. Lunch was provided by the Lumberjack – Food choice was spaghetti or Cheeseburger plus a beverage – it was good.

As shared last month, Board members are up for Election in August 2017. Nominations were accepted at the meeting. Nominees include: Tom Ross, Harvey Thompson, John Kielkucke, Danny Coyle and Bill Roettger. There are 3 positions available - election/voting will take place in August.
